Dear Taylor Community,

Yesterday was an ironic day here at Taylor Community. After weeks of advocating for a loosening of restrictions for licensed building residents, NH DHHS Commissioner Lori Shibinette did just that at a 3 pm press conference. At the same time, we were hustling to re-test residents and staff after receiving word that two tests from our latest round of employee and staff COVID-19 tests were inconclusive. One inconclusive test involved a resident in one of our licensed buildings, while the other involved a staff member who does not work in the licensed buildings. We had strong reason to believe that both of these tests were compromised at the lab, but nonetheless, out of an abundance of caution, we immediately re-tested and implemented additional safety precautions.

I am pleased to report that we have since received word that the employee's test was, indeed, negative and the resident's second test was negative as well. Out of an abundance of caution, we have re-tested the licensed building resident for a third time and we hope to receive those results today. We are working closely with the NH Department of Public Health and following their guidelines. If the results of the third test determine that Taylor is, in fact, dealing with the onset of COVID-19, we will be sure to let everyone know. As of right now, we do not believe this is the case.

This process has reminded us how fluid this COVID-19 situation is, and that we have to remain vigilant and be ready to re-test at a moment's notice. My thanks to our Infection Control nurse, Crystal Hardy, along with our entire clinical team, who continue to go above and beyond to keep our residents and staff safe. Not only do they regularly test our staff and residents on a 10 day rotation, but they also showed us how quickly they respond when called upon.

As I promised you at the very beginning of this COVID-19 pandemic, we will always be up front and transparent with our staff, residents and their families. This is why we chose to keep you up to date in real time yesterday as soon as we received this information, and why we will continue to do so in the future. We will be in touch as soon as we receive results of the resident's third test.

Assuming it comes back negative, our team will discuss how best to move forward with the loosening of restrictions in our licensed buildings. But, as you can understand, we will not be making any decisions immediately. My continued thanks for placing your trust in us and for your continued communications. We value the relationships we share with residents and their families and encourage you to contact us at any time with questions or concerns. We are here for you.

Be safe, wear a mask, and please keep washing your hands.
